### I. Introduction

While cookies may be pseudonymous or not directly linked to an individual, they are treated as personal data if they become identifiable when combined with other information.

We value your privacy and are committed to protecting your personal data and rights. Sustainable Lawyer operates in accordance with all relevant legislation, particularly the Personal Data Protection Law No. 6698 (“**KVKK**”), and endeavors to build and maintain a relationship of trust with you. As part of this commitment, we process your personal data, including cookies, with the utmost care and in compliance with legal requirements. Our Cookie Policy aims to provide transparent and detailed information about the collection and processing of your personal data through cookies on our website <https://www.sustainablelawyer.co/> as well as how you can manage these cookies. We prioritize the security of your data and have implemented necessary measures to safeguard it.

### II. Collection Methods for Your Personal Data

### III. Cookie Types and List by Purpose:

#### (i) Essential Cookies:

However, in adherence to the regulations stipulated in Articles 8 and/or 9 of the KVKK, your personal data collected through cookies may be shared with suppliers, business partners, information technology service providers, authorized public institutions and organizations, and individuals legally authorized for such purposes.

**IV. Your Rights**

As the data subject, we hereby inform you of the rights afforded to you under Article 11 of the KVKK

- The right to learn whether your personal data is being processed,
- The right to request information if your personal data has been processed,
- The right to learn the purpose of processing your personal data and whether they are being used in accordance with that purpose,
- The right to know the third parties, both domestically and abroad, to whom your personal data has been transferred,
- The right to request the correction of your personal data in case they are incomplete or inaccurately processed, and to request notification of such corrections to third parties to whom your personal data has been transferred,
- The right to request the deletion or destruction of your personal data if they are processed in accordance with the KVKK and other relevant laws, but the reasons requiring their processing have ceased to exist, and to request notification of such deletion or destruction, as well as of any corrections made to your personal data, to third parties to whom your personal data has been transferred,
- The right to object to the occurrence of a result adverse to yourself as a result of the analysis of your processed data exclusively through automated systems,
- The right to request compensation for any damages incurred due to the unlawful processing of your personal data.
